It was suggested that Parish Council Chairman Councillor Fairman contacts Rev Bryan to outline the proposals for the refurbishment and that all adjoining properties should be kept informed at all stages.

It was proposed by Councillor Fairman and seconded by Councillor Greenaway that plans are drawn for the toilets with a ridge roof and that the access to the toilets remains as per the existing drawings one toilet to be accessed from outside and one from the Institute building and that the drawing submitted will include air source heat pump. This proposal received the support of the Council.
